Mayor Mahan and members of the City Council,

Re: 10.4 Pleasant Hills Golf Course Guiding Principles

As an organization dedicated to ensuring every resident of Santa Clara County has equitable access to a safe, stable home they can afford, SV@Home is pleased to see the Council continue to engage with the opportunity for the vibrant, diverse, and sustainable development of the former Pleasant Hills Golf Course site. The 115-acre site is large enough to meet a variety of community needs, including affordable and market-rate housing, neighborhood-serving retail and commercial space, and open space. Given its scale and location near a future VTA Light Rail extension and future redevelopment opportunities at the nearby Eastridge Mall and Reid-Hillview Airport, this is a project with regional significance.

We value the ongoing efforts of city staff to engage in community outreach and a robust community engagement process, resulting in the Guiding Principles document under Council consideration. SV@Home was pleased to participate in the community engagement and visioning process, as both stakeholders and residents of East San Jose, and appreciate the broad range of perspectives shared there. The Guiding Principles summarize the results of the initial community engagement process and are one of the criteria that will be weighed in the review of an eventual development application along with the proposed development's conformity with Council direction, City goals and policies, the City's priorities for density and affordability, and the fiscal impact study.

We appreciate the memo authored by the Mayor and Councilmembers Candelas, Ortiz, Foley, and Jimenez, which recommends a fiscal analysis of the impacts of land uses and densities on the site once a complete development application has been received and an analysis of options for the creation of a special assessment district for the site. We urge the Council to accept the Pleasant Hills Golf Course Guiding Principles as recommendations from the community along with the recommendations in the Mayor/Candelas/Ortiz/Foley/Jimenez memo. Together, the Guiding Principles, memo recommendations, and established criteria for evaluation of the eventual development application empower staff to respond to council direction and regulatory requirements and ensure the project responds to the needs of the City and the broader community.

Dear City Council,

I support the creation of a vibrant, sustainable development at the Pleasant Hills Golf Course Site. I want a proposal that creates a lot of housing, including affordable housing, which is our region's greatest need. Unfortunately, the initial proposal from the developer won't accomplish these goals.

PLEASE REQUIRE HIGHER DENSITY DEVELOPMENT AND AFFORDABLE HOUSING INCLUDED ON THIS SITE. We can't afford to continue with more low density sprawl development, it is not sustainable.

While the Guiding Principles you're voting on this week reflect a quality community engagement process by the City, they miss some realities.

I urge you to look past the Guiding Principles to tackle what is already in front of us, as well as what is hurtling toward us. We have a housing crisis and a worsening climate. San Jose is mandated to build 62,000 new homes in the next eight years. If this project were built as is, the City would only contribute to the mounting consequences

of sprawl. If we build like we're stuck in the past, we'll face worse traffic, greater carbon emissions, and even fewer affordable housing options, exacerbating already severe challenges. These are challenges San Jose residents gave voice to during the community engagement process. Building a project like the initial proposal means losing valuable open space and further reliance on cars.

We need a plan that looks to the future. A plan that addresses our housing and sustainability needs by maximizing density, affordable housing, green space, and transportation options. Let's ensure that whatever gets built properly addresses our entire community, not just the folks who attend community meetings.

The developer's current proposal isn't sufficient. Tell the developers to go back to the drawing board. We need a plan that prioritizes the needs of all San Jose residents, not just a few.

As an organization dedicated to ensuring every resident of Santa Clara County has equitable access to a safe, stable home they can afford, SV@Home is pleased to see the Council continue to engage with the opportunity for the vibrant, diverse, and sustainable development of the former Pleasant Hills Golf Course site. The 115-acre site is large enough to meet a variety of community needs, including affordable and market-rate housing, neighborhood-serving retail and commercial space, and open space. Given its scale and location near a future VTA Light Rail extension and future redevelopment opportunities at the nearby Eastridge Mall and Reid-Hillview Airport, this is a project with regional significance.

We value the ongoing efforts of city staff to engage in community outreach and a robust community engagement process, resulting in the Guiding Principles document under Council consideration. SV@Home was pleased to participate in the community engagement and visioning process, as both stakeholders and residents of East San Jose, and appreciate the broad range of perspectives shared there.
