A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE AUTHORIZING “FREE USE” FOR THE EAST SIDE UNION HIGH SCHOOL DISTRICT CAREER FAIR AT THE CITY HALL ROTUNDA, COUNCIL CHAMBERS, AND WING COMMITTEE ROOMS ON APRIL 26, 2024

WHEREAS, in June 2019, the Council of the City of San José (“City”) adopted Schedule of Fees Resolution No. 79138 for the fees and charges for City Hall Facility and Plaza Use; and

WHEREAS, Resolution No. 79138 authorizes City Departments to have “Free Use” of the City Hall Facility and Plaza for events that 1) qualify as official City business; 2) are free and open to the public; 3) occur on a Sunday through Friday; and 4) are booked thirty (30) days in advance; and

WHEREAS, Council District 7 and the East Side Union High School District (“ESUHSD”) will co-host a Career Fair at the City Hall Rotunda, Council Chambers, and Wing Committee Rooms on April 26, 2024 for approximately 300 students from ESUHSD; and

WHEREAS, the purpose of the Career Fair is to provide ESUHSD students with opportunities to connect with local employers in person; and

WHEREAS, “Free Use” does not apply to events which are not free and open to the public, and, therefore, Council approval is necessary to authorize free use of the City Hall Rotunda, Council Chambers, and Wing Committee Rooms for the Career Fair; and

WHEREAS, the Career Fair occurs on a weeknight and has been booked more than thirty (30) days in advance, in compliance with Resolution No. 79138; and

WHEREAS, the City finds that the Career Fair qualifies as official City business through its public benefit in connecting ESUHSD students with local employers; and

WHEREAS, the City desires to allow for the free use of the City Hall Rotunda, Council Chambers, and Wing Committee Rooms for the Career Fair on April 26, 2024;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

The City Council hereby authorizes “Free Use” of the City Hall Rotunda, Council Chambers, and Wing Committee Rooms for the Career Fair on April 26, 2024, co-hosted by City Council District 7 and the East Side Union High School District, because of the public benefit that the Career Fair will provide to the City of San José and its youth.
