# COUNCIL MEMO RECOMMENDATION

Either:

Adopt Staff Report recognizing the County Ordinance.

Or:

Approve the City Urgency Ordinance, Ordinance and Resolution.

# KEY EVENTS

March 16 - Governor Executive Order allows Local Moratorium.

March 17 - City Approves Residential Moratorium and instructs City Attorney to draft Small Business Moratorium.

March 24 - County Adopts Residential and Commercial Ordinance.

# COUNTY ORDINANCE

1. Covers All Small Business Commercial and Residential Tenants in the Incorporated & Unincorporated parts of County, including San Jose tenants.
2. Commercial includes properties used for business, income producing purposes, or other nonresidential purposes. This, includes nonprofits.
3. Tenants must show substantial loss of income due to COVID-19.
4. 120 Day Repayment Period Starts Once Moratorium Ends. Late fees prohibited.

# CITY VS. COUNTY MORATORIUM

## Similarities:

- Moratorium through May 31, 2020, unless State extends.
- Applies to Same Small Business Tenants
- Definition of Substantially Impacted

## Differences:

- County repayment period explicitly provides 120 days
- City provides moratorium doesn't apply to abandoned property. State law provides process.
