

RESOLUTION NO.

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE NOMINATING THE GEOGRAPHICALLY DEFINED AREA OF ALAMEDA PARK/SCHIELE AVENUE AS A CITY LANDMARK HISTORIC DISTRICT AND INITIATING PROCEEDINGS PURSUANT TO CHAPTER 13.48 OF THE SAN JOSE MUNICIPAL CODE TO DESIGNATE THE GEOGRAPHICALLY DEFINED AREA OF ALAMEDA PARK/SCHIELE AVENUE AS A CITY LANDMARK HISTORIC DISTRICT OF SPECIAL HISTORICAL, ARCHITECTURAL, CULTURAL, AESTHETIC OR ENGINEERING INTEREST OR VALUE OF AN HISTORICAL NATURE

WHEREAS, Chapter 13.48 of Title 13 of the San José Municipal Code provides for the designation of any geographically defined area of special historical, architectural, cultural, aesthetic or engineering interest or value of an historical nature as a City Landmark Historic District by the City Council of the City of San José; and

WHEREAS, Chapter 13.48 of Title 13 of the San José Municipal Code provides that any geographically defined area can be nominated as a City Landmark Historic District by the City Council, the Historic Landmarks Commission, the Planning Commission or by application of persons who own sixty percent of the land proposed to be included in the district or the authorized agents of such owners; and

WHEREAS, Chapter 13.48 of Title 13 of the San José Municipal Code provides that before this Council may designate any geographically defined area as a City Landmark Historic District, it shall hold at least one public hearing on such proposed designation, and that before it holds said public hearing, the Council shall refer said proposed designation to the Historic Landmarks Commission and the Planning Commission of the City of San José for their consideration at a public hearing, and for their report and recommendation hereon; and

WHEREAS, said Council desires to hold a public hearing on such proposed designation as described hereinafter in Section 1 of this resolution;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN JOSE AS FOLLOWS:

SECTION 1. The City Council of the City of San José, hereby initiates proceedings on its own motion to designate the geographically defined area of Alameda Park/Schiele Avenue, generally bounded on the east by Stockton Avenue, on the south by Pershing Avenue, on the west by Hoover Avenue and on the north by the north side of Schiele Avenue and a portion of the southerly side of Schiele Avenue, as a City Landmark Historic District of special historic, architectural, cultural, aesthetic or engineering interest or value of an historical nature, in accordance with Chapter 13.48 of Title 13 of the San José Municipal Code.

SECTION 2. The above stated proposed City Landmark Historic District designation is hereby referred to the Historic Landmarks Commission and Planning Commission of the City of San José for their consideration at a public hearing and for their report and recommendation thereon. The City Clerk is hereby directed to forward a copy of this resolution to the Historic Landmarks Commission and Planning Commission and to cause notice of said Commissions' hearings on this proposed designation to be given in the manner prescribed in said Chapter 13.48 of Title 13.

SECTION 3. This Council will hold a hearing on such proposed landmark designation on September 24, 2024, at the hour of 1:30 p.m. of said day, in the Council Chambers of the City of San José, in City Hall, 200 East Santa Clara Street, San José, California, or at its earliest next regular meeting in compliance with said Chapter 13.48 of Title 13 of the San José Municipal Code. The City Clerk is hereby directed to give notice of the hearing in the manner prescribed in said Chapter 13.48 of Title 13.
