BUSINESS IMPROVEMENT DISTRICT (BID)

BIDs are formed pursuant to the California Parking and Business Improvement Area Law of 1989.

BID law allows for the creation of special benefit assessment districts to raise funds within a specific geographic area.

BIDs allows business owners to organize their efforts and raise funds exclusively for the benefit of the district.

Business owners within the assessment district boundaries fund the district, and 99% of funds are used to provide services desired by and benefitting businesses within the district.

City Council renews the BID annually.

ABOUT THE CORRIDOR

The Tully Road - Eastridge business corridor stretches from Highway 101 to Capitol Expressway, and is an extensive and active cultural business district.


~ 500 Businesses

Anchors are *Eastridge Mall* on the east end and *Chuck E. Cheese* on the west end. The corridor falls within Council Districts 7 and 8.



Business Category	Annual Assessment Rates	Number of Business	Assessment Revenue
Financial Institutions	\$450	5	\$2,250
Retail/ Hospitality	\$385	329	\$126,665
Non-retail/ Professional Services	\$300	123	\$36,900

Assuming 65% of assessment revenue is collected, **projected revenue for the first fiscal year is \$108,000.**
