**A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE AUTHORIZING “FREE USE” OF THE CITY HALL ROTUNDA ON JUNE 10, 2024 FOR THE 2024 YOUTH COMMISSION ANNUAL RECOGNITION AWARDS EVENT CO-HOSTED BY THE LIBRARY DEPARTMENT**

**WHEREAS**, in June 2019, the City adopted Schedule of Fees Resolution No. 79138 for the fees and charges for City Hall Facility and Plaza Use; and

**WHEREAS**, Resolution No. 79138 authorizes City Departments to have “Free Use” of the City Hall Facility and Plaza for events that 1) qualify as official City business; 2) are free and open to the public; 3) occur on a Sunday through Friday; and 4) are booked thirty (30) days in advance; and

**WHEREAS**, the Library Department (“Library”) will co-host the 2024 Youth Commission Annual Recognition Event, a private event at the City Hall Rotunda on Monday, June 10, 2024, attended by Youth Commissioners, Youth Advisory Council Members, and Youth Commissioners’ families; and

**WHEREAS**, this event will raise awareness of the Library's youth empowerment efforts with the youth attendees, invited Councilmembers, and City Staff; and

**WHEREAS**, the purpose of this event is to honor and showcase the achievements, hard work, and dedication of the Youth Commissioners and youth from the Youth Advisory Councils who have played a pivotal role in the Youth Commission's annual work plan; and

**WHEREAS**, “Free Use” does not apply to events which are private and not open to the public, and, therefore, Council approval is necessary to authorize free use of the City Hall Rotunda for the 2024 Youth Commission Annual Recognition Event; and

**WHEREAS**, the 2024 Youth Commission Annual Recognition Event occurs on a weeknight and has been booked more than thirty (30) days in advance, in compliance with Resolution No. 79138; and

**WHEREAS**, the City finds that the 2024 Youth Commission Annual Recognition Event qualifies as official City business since the Youth Commission is an official advisory commission to the Mayor and City Council and its role includes empowering and encouraging youth to be civically engaged through local and city-wide events and initiatives; and

**WHEREAS**, the City desires to allow for the free use of the City Hall Rotunda for the 2024 Youth Commission Annual Recognition Event on Monday, June 10, 2024;

**NOW, THEREFORE**, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

The City Council hereby authorizes “Free Use” of the City Hall Rotunda for the 2024 Youth Commission Annual Recognition Event on Monday, June 10, 2024, co-hosted by the Library Department because of the public benefit that the Youth Commission provides in the development of policy recommendations concerning youth, support youth who serve their community through civic engagement and participation, and promoting resources and opportunities that provide equitable access and support to marginalized youth communities in the City of San José.
