ORDINANCE NO.

AN UNCODIFIED ORDINANCE OF THE CITY OF SAN JOSE APPROVING THE ANNUAL BUDGET REPORTS FOR CITY OF SAN JOSE MAINTENANCE DISTRICTS 1, 2, 5, 8, 9, 11, 13, 15, 18, 19, 20, 21, AND 22 FOR FISCAL YEAR 2024-2025 AS FILED OR MODIFIED BY THE CITY COUNCIL, AND CONFIRMING AND LEVYING THE INDIVIDUAL ASSESSMENTS, AS FILED OR MODIFIED BY THE CITY COUNCIL, SPECIFIED IN THE RESOLUTIONS

WHEREAS, on June 4, 2024, the City Council adopted resolutions approving the Annual Budget Reports for City of San José Maintenance Districts 1, 2, 5, 8, 9, 11, 13, 15, 18, 19, 20, 21, and 22 for Fiscal Year 2024-2025, as filed or modified by the City Council, confirming and levying the individual assessments as filed or modified by the City Council, and directing the Director of Public Works to deliver the assessment roll to the County of Santa Clara for collection with the property taxes; and

WHEREAS, pursuant to the provisions and requirements of the California Environmental Quality Act of 1970, together with related State CEQA Guidelines and Title 21 of the San José Municipal Code, the Director of Planning, Building and Code Enforcement on April 9, 2024, determined that the provisions of this Ordinance are categorically exempt under CEQA Guidelines 15301 (Existing Facilities), File No. ER24-086; and

WHEREAS, the City Council of the City of San José is the decision-making body for this Ordinance and has reviewed, considered, and upheld the exempt determination prior to taking any action on the Ordinance;
