**SUBJECT: DELEGATION OF AUTHORITY TO AWARD PAVEMENT  
CONSTRUCTION CONTRACTS**

## **RECOMMENDATION**

Adopt a resolution authorizing the Director of Transportation to:

- (a) Award and execute a contract for the construction of the 10362 – 2024 LS Remove & Replace Project to the lowest responsive, responsible bidder in an amount not to exceed \$6,000,000;
- (b) Award and execute a contract for the construction of the 10363 – 2024 LS Sealing Project to the lowest responsive, responsible bidder in an amount not to exceed \$6,000,000; and
- (c) As to each of the above construction contracts:
  - 1) Decide any timely bid protest(s), make the City's final determination as to the lowest responsive bidder that is responsible, or reject all bids and rebid the projects; and
  - 2) Approve a construction contingency of 10%.

## **SUMMARY AND OUTCOME**

These contracts will provide preventative maintenance along the Local Street Network in the 2024 construction season. The work done through these projects is the preparation work and the final surface sealing application to seal the surface of the roadway to preserve the pavement condition.

Approval of the resolution authorizing the Director of Transportation to award and execute these contracts will expedite the contract award and execution process and ultimately the start of

construction. The resolution approval will also allow for both projects to complete construction before the winter months begin and inclement weather causes impacts to the project schedules. With the expedited process, staff anticipates construction of the 10362 – 2024 LS Remove & Replace Project to start in July 2024 with project completion by September 2024. Staff anticipates construction of the 10363 – 2024 LS Sealing Project to start in August 2024 with project completion by November 2024, weather permitting.

The 10% contingency will provide funding for any unanticipated work necessary for the proper completion or construction of the projects.

## **BACKGROUND**

The Department of Transportation (DOT) is planning to seal 61 miles of streets out of the approximate 177 miles planned for maintenance on the Local Street Network in the 2024 construction season as a preventative maintenance measure to extend the useful life and reduce long-term maintenance costs to the City.

Preventive pavement maintenance is typically performed in two separate phases: preparation and final surface sealing application. The preparation phase includes American with Disabilities Act curb ramp installations and retrofits prior to the commencement of the pavement treatment. Streets to be sealed will also require the removal and replacement of any structurally failed areas of pavement. The final surface treatment is applied to the entire street after preparation phases are complete.

To decrease the overall timeframe for completing the preparation work, DOT is managing multiple projects for the concrete and ramp improvements, most of which are currently in the construction phase. These projects encompass both the preparation phase and the final phase of construction for sealing streets.

The City's Local and Neighborhood Streets Network is organized into 135 geographically contiguous "Pavement Maintenance Zones." The zones were established several decades ago to support efficient planning and delivery of paving projects, maximize the amount of paving work completed at one time within a neighborhood area, and provide geographic spread of pavement maintenance across the City.

DOT utilizes a Pavement Management System to collect and store roadway condition data that is used to generate a candidate list of streets to be considered for the annual pavement maintenance program. The candidate list is then thoroughly analyzed by staff using the following criteria to create the final list of streets:

- Funding availability and funding use restrictions;
- Total miles of streets in reconstruction and rehabilitation category;
- Streets not affected by current or future street related projects;
- Maintenance history and prescribed treatment schedules;

- Relative location of street segments to create multiple, continuous segments, consistency within neighborhoods, and project efficiency;
- Multi-year geographic spread across the City and street network;
- Number of public traffic attraction facilities, such as schools, hospitals, libraries, community centers, etc.; and,
- Community and City Council Office feedback regarding roadway conditions and priority street segments.

In 2021, DOT included equity as an additional criterion for zone selection. DOT staff cross-referenced the selected zones with census tracts designated by the Metropolitan Transportation Commission as “Equity Priority Communities,” formerly known as “Communities of Concern” to better track equity in service delivery. Most recent results confirmed that 238 out of 265 miles (roughly 90%) of local and neighborhood streets designated in Equity Priority Communities areas will be maintained by the end of the current three-year plan (2026).

Since 2019, DOT has maintained a total of 163 Equity Priority Communities miles and will be maintaining an additional 34 Equity Priority Communities miles in 2024, which is roughly 19% of the 177 miles of local and neighborhood streets selected for maintenance in 2024. These two projects include approximately 15 miles of streets within Equity Priority Communities.

The **attachment** to this memorandum contains the list of streets to be sealed as part of both projects. The list may change if unforeseen circumstances arise or new information regarding other projects becomes available.

Construction of the 10362 – 2024 LS Remove & Replace Project is scheduled to begin in July 2024 with project completion by September 2024 and construction of the 10363 – 2024 LS Sealing Project is scheduled to start in August 2024 with project completion in November 2024.

## **ANALYSIS**

Both projects will be using Santa Clara Valley Transportation Authority 2016 Measure B (Complete Streets - use for residential) fund to prepare and seal approximately 61 miles of City local and neighborhood streets. Staff will evaluate bids submitted and provide a recommendation to the Director of Transportation for a final determination as to the lowest responsive, responsible bidder to award the contract.

Authorizing the Director of Transportation to award and execute the contracts for construction of the projects will reduce the schedule by approximately six to eight weeks, by shortening the typical timeline for contract award and execution. This time savings further provides the necessary flexibility for the project team to accommodate potential delays, such as those caused by unforeseen site conditions, and should allow for sufficient time for both projects to complete construction before the winter months begin and inclement weather causes impacts to the project schedules.

*Contingency*

San José Municipal Code Section 27.04.050 provides for a standard contingency of 10% on all public works contracts except those involving the renovation of a building or buildings. The standard contingency is appropriate for these projects.

*Wage Theft Prevention Policy Check*

The Office of Equality Assurance will review bidders for compliance with the City's Wage Theft Prevention Policy before awarding the projects.

*Project Labor Agreement Applicability*

The Project Labor Agreement is applicable to both projects because the Engineer's Estimates are over \$1.22 million.

*Local and Small Business Outreach*

Both projects will be publicly advertised through the City's contract portal, which will notify all available and capable contractors, including qualified local and small businesses. Each bidder will be reviewed to determine if the prime and subcontractors are local and small business enterprise for documentation purposes.

**EVALUATION AND FOLLOW-UP**

No additional follow-up action with City Council is expected at this time.

**COST SUMMARY/IMPLICATIONS**

These projects support the Transportation and Aviation Services City Service Area goal to *Preserve and Improve Transportation Assets and Facilities*. By performing pavement maintenance, the extension of the useful life of the project streets will defer more costly reconstruction. The source of funding for these projects is through the 486 – VTA Measure B 2016 (Complete Streets - use for residential) fund. These projects will have a net zero impact to the General Fund as the standard in-house operating and maintenance costs are already included in DOT's annual budget.
