A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE AUTHORIZING “FREE USE” FOR THE PRIVATE, INVITATION-ONLY UNITED STATES POSTAL SERVICE SAN JOSE POSTMASTER’S INSTALLATION EVENT AT THE CITY HALL ROTUNDA ON AUGUST 21, 2024

WHEREAS, in June 2019, the Council of the City of San José (“City”) adopted Schedule of Fees Resolution No. 79138 for the fees and charges for City Hall Facility and Plaza Use; and

WHEREAS, Resolution No. 79138 authorizes City Departments to have “Free Use” of the City Hall Facility and Plaza for events that 1) qualify as official City business; 2) are free and open to the public; 3) occur on a Sunday through Friday; and 4) are booked thirty (30) days in advance; and

WHEREAS, Council District 9 and the United States Postal Service (USPS) Postmaster’s Office will co-host the USPS San José Postmaster’s Installation event at the City Hall Rotunda on August 21, 2024; and

WHEREAS, the purpose of the USPS San José Postmaster’s Installation event is to welcome Richard Keppeler as the new USPS Postmaster for the City of San José; and

WHEREAS, “Free Use” does not apply to events which are not free and open to the public, and, therefore, Council approval is necessary to authorize free use of the City Hall Rotunda for the USPS San José Postmaster’s Installation event; and

WHEREAS, the City finds that the USPS San José Postmaster’s Installation event qualifies as official City business through its public benefit of installing Richard Keppeler as the new USPS Postmaster for the City of San José, who will ensure that San José residents and businesses receive proper mail service and who will manage USPS jobs

and schedules, which is an important part of making sure that San José is a great place to live and work; and

WHEREAS, the City desires to allow for the free use of the City Hall Rotunda for the USPS San José Postmaster’s Installation event on August 21, 2024;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

The City Council hereby authorizes “Free Use” of the City Hall Rotunda for the USPS San José Postmaster’s Installation event on August 21, 2024, co-hosted by City Council District 9 and the USPS Postmaster’s Office, because of the public benefit it will provide to the City of San José.
