Background

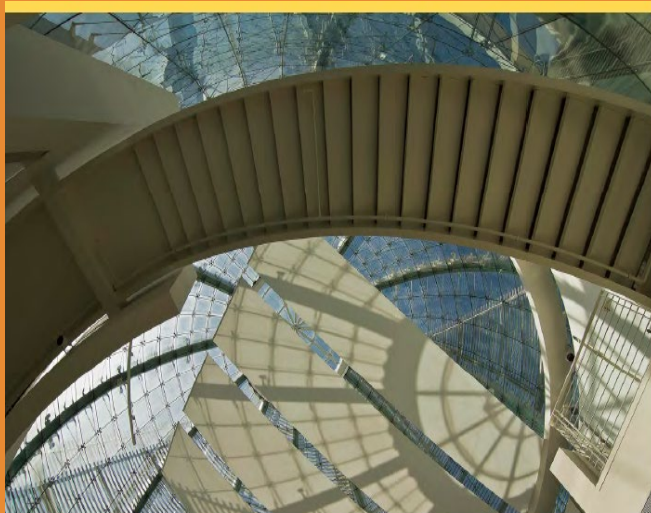
- Office of Immigrant Affairs established in 2015

Action Items:

1. Develop evaluation and data collection plan;
2. Improve feedback and accountability, through an advisory group;
3. Integrate specific goals around immigrant inclusion and language access into racial equity action plans;
4. Increase partnership with City departments, related to equity planning, community engagement, and language access;
5. Focus on job training and opportunities with the goal of moving immigrant residents towards middle skills jobs; and
6. Explore greater collaboration with the philanthropic and private sectors.

Community Engagement Process

- Phase 1, Aug 2019 Visioning and high-level process
- Phase 2, Sept 2019 Broad community input
- Phase 3, Nov 2019 Prioritization of strategies
- Phase 4, Jan 2020 Review draft strategies
- Phase 5, Nov 2020 Reflect and revise



Recommendations from the Neighborhood Services & Education Committee

May 20, 2021



1. to coordinate further engagement with other council offices to be included in the Welcoming San José (WSJ) Plan;
2. to refrain from and discontinue the use of the term “Latinx” until it can be defined with further analysis, research, community engagement, and feedback from immigrant communities on this term;
3. to change references to addressing Anti-Blackness in immigrant communities in the WSJ Plan to Anti-hate and Anti-violence;
4. to address human trafficking, sex trafficking, gender identity, domestic violence, and sexual orientation issues that impact the refugee and immigrant communities into the report and Welcoming San José plan;
5. to create a matrix with measurable goals and outcomes to hold City Departments accountable for racial equity action plans; and
6. to return to the Neighborhood Services and Education Committee with a follow up and further breakdown of the workplan in response to the feedback and research that’s been received based on further outreach.

Welcoming San Jose Plan, 2021-2024

1. Leadership and Communications
2. Access and Engagement
3. Education and Economic Opportunity
4. Safe Communities

Leadership and Communications

Establish equitable systems, policies, and practices throughout the City that create a welcoming and inclusive environment that allows immigrants, residents of color, and all people of San José to thrive.

- Immigrant-friendly policies and practices and support of immigrant-friendly legislation
- Diversity, Equity, and Inclusion (DEI) training for City staff
- City's active participation in community events to connect long-term residents and immigrant/refugee communities
- City-County coordination/Coordination with City Council offices

Access and Engagement

Improve immigrant access to City information and services, and augment immigrant participation in civic life.

- City-wide standard for equitable public outreach and engagement
- City-wide Language Access Implementation Plan
- Partnership on an English-Learners Civics curriculum
- Naturalization and voter registration support, including citizenship workshops, partnering with smaller/newer immigrant and refugee groups
- Address hate crimes and violence in immigrant communities

Education & Economic Opportunity

Advance educational and economic opportunities among immigrants and refugees through job skills training, strengthening career pathways, promotion of entrepreneurship, small business retention and growth, and financial literacy.

- Convene partners to expand job training towards middle-skills jobs
- Increase participation in ESL
- Support immigrant entrepreneurship and financial literacy
- Facilitate credentialing processes
- Create career pathways for foreign-trained professionals

Safe Communities

Foster trust and communication between law enforcement, local governments, immigrants, and the community at large.

- Continue support of the Rapid Response Network
- Engage immigrant communities in “Reimagining Community Safety” and build relationships between the Police Department and immigrant/refugee communities, especially teens and young adults
- Engage in additional work with OEM around linguistically and culturally responsive emergency planning
