City Attorney, Nora Frimann indicated that staff will add to the draft presented to include language to that effect. Mayor Sam Liccardo seconded the motion.

Adopt the prior recommendations and appointments articulated in Mayor's January 12, 2021 memorandum, Items 1-4, with changes as noted: Councilmember Arenas replacing Councilmember Esparza on the Rules Committee, and with Councilmember Foley replacing Councilmember Arenas on the Transportation and Environment Committee.

1. Apprise the council of the Mayor's appointments for the Rules Committee, selecting Councilmember Cohen, Councilmember Davis, *Councilmember Arenas*, Vice Mayor Jones, and Councilmember Peralez. Vice Mayor Jones will serve as Chair, and Councilmember Peralez will serve as Vice Chair.

(2) Paul Soto thanked everyone for bringing forth this topic, recounting the pain and tyranny that still resonates within survivors.

*Mayor Sam Liccardo adjourned for a break at 6:07 p.m., and the Council Meeting reconvened at 6:45 with all Councilmembers present.*

(2) Blair Beekman spoke to state-sponsored extremism and spoke to Deputy Chief Mata's potential. (3) Speaker "5140" expressed criticism of the San José PD. (4) Sharon Denoa spoke to the need for a cultural shift with respect to diversity.

Motion: Councilmember Raul Peralez moved approval of the Statement of Policy including City Council Questions related to the selection of a new Chief of Police as provided by the Mayor, Vice Mayor and Councilmembers Arenas, Cohen, Esparza, Jimenez and Peralez. The motion was seconded by Vice Mayor Chappie Jones.

Councilmember Maya Esparza requested a friendly amendment, asking the reason certain applicants withdrew from the process be discussed in either Open or Closed Session. Additionally, Vice Mayor Chappie Jones asked that the City Manager be given flexibility to consolidate or combine similar questions. The friendly amendments were accepted.

Action: On a call for the question, the motion was carried unanimously, the Statement of Policy was adopted, and City Council Questions related to the selection of a new Chief of Police were accepted including questions provided by the Mayor, Vice Mayor and Councilmembers Arenas, Cohen, Esparza, Jimenez and Peralez, with the City Manager allowed flexibility to consolidate or combine similar questions with approval of those providing the questions. City Manager, David Sykes was directed to agendize, for either open or closed session, the reason for the withdrawals of two of the applicants. (11-0.)

They were grandparents, parents, sons, and daughters. Many of them put their life on the line as first responders, health care professionals, and essential workers. Unfortunately, they are no longer with us. However, we must always honor their memory. As a nation, a state, and a city, we remember the thousands of lives lost to this disease.
