RECOMMENDATION

1. Retroactively approve the Global Innovation Summit event which occurred on October 13, 2023 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses, or community groups to support this event.
3. Place this item on the January 9, 2024, Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council-sponsored Special Events and the proposed use of any funds.

The Global Innovation Summit was an event that strengthened the bond between our local innovation industry leaders and the international community (via Consul-General Offices). The event started with an Opening Keynote by the Mayor where he discussed the recently passed Innovation Economic Development plan which passed via Rules Committee. There were then two panels – one on Semiconductors and the other on Sustainability – that were a mix of academia (an SJSU professor moderated one of the panels), industry (local companies such as Lyten spoke on the panel), City Staff (the Assistant Direct of San Jose Clean Energy), and industry associations (a NextFlex representative spoke).

ANALYSIS

Retroactively approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Mayor Matt Mahan will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable the Mayor's Office, City departments, and the Office of the City Clerk to proceed with any follow-up items connected to the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.

The Office of the City Clerk will post the item on the City's Website for the January 3, 2024, Rules Committee Agenda and the January 9, 2024, City Council Agenda.
