RECOMMENDATION

1. Retroactive Approval of the District 2 Winter Holiday Party, on December 6, 2023, at Southside Community Center; and
2. Retroactive Approval of the District 2 Diwali Celebration, on November 4, 2023, at Southside Community Center; and
3. Approve the expenditure of District 2 office budget funds for event costs and facility rental fees.
4. Approve and accept donations from various individuals, businesses and/or community groups to support the events.
5. Place the item on the January 9, 2024, Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The District 2 Winter Holiday Party was held on December 6, 2023 at Southside Community Center at 5585 Cottle Rd, San Jose, CA 95123. The event was jointly sponsored by the Office of County Supervisor Sylvia Arenas. The holiday party was a community gathering for residents of District 2 to celebrate the holiday season and engage with their elected representatives. The event was free and open to the public.

The District 2 Diwali Celebration took place on November 4, 2023, at Southside Community Center 5585 Cottle Rd, San Jose, CA 95123. The event was a cultural celebration in honor of

Diwali, the Festival of Lights. The event was co-hosted by the Great Oaks Neighborhood Association. The event provided District 2 residents an opportunity to celebrate Diwali and learn about the neighborhood association. The event was free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Jimenez will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 2, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
