


2.12 Google, LLC Donation of Trees for Citywide Planting.

Recommendation:

Adopt a resolution accepting a donation from Google, LLC of 544 trees that are valued at \$258,315 to be planted throughout the City of San José in median islands, road backups, and parks.

SUBJECT: GOOGLE, LLC DONATION OF TREES FOR CITYWIDE PLANTING

RECOMMENDATION:

Adopt a resolution accepting a donation from Google, LLC of 544 trees that are valued at \$258,315 to be planted throughout the City of San José in median islands, road backups, and parks.

BASIS FOR RECOMMENDATION:

The recommended action allows the Department of Transportation and the Parks, Recreation, and Neighborhood Services Department to accept a donation from Google, LLC of 544 trees to be planted citywide.

As described in the Community Forest Management Plan, tree canopy cover decreased from 15.36 percent in 2012 to 13.54 percent in 2018. Since the Community Forest Management Plan adoption, the Department of Transportation and the Parks, Recreation, and Neighborhood Services Department are on track to plant and establish over 2,000 trees per year by partnering with Our City Forest and contractors. Due to high demand of good quality tree stock in the nursery industry, sourcing trees is one of the challenges faced when executing planting projects.

Google, LLC has cultivated a surplus of high quality, native trees that will make excellent shade trees for San José. Areas for planting these trees have been identified and prioritized, especially in areas with the lowest canopy cover or where trees have been lost. These donated trees will be planted by Our City Forest and contractors. The donated trees will continue to be stored at their point of origin, in Gilroy, California, and the vendor or planting partner responsible for a planting project will pick trees up directly and plant them in San José when needed. Staff's goal is to plant all the donated trees by the fall of 2024.

Commission Recommendation/Input: No commission recommendation or input is associated with this action.

COST AND FUNDING SOURCE:

The recommendation in this action request will allow the City to accept trees that are valued at \$258,315. Existing funding sources for tree planting efforts will be utilized to plant, water, and establish the donated trees.

**A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN JOSE ACCEPTING A DONATION FROM GOOGLE,
LLC OF 544 TREES THAT ARE VALUED AT \$258,315 TO
BE PLANTED THROUGHOUT THE CITY OF SAN JOSE IN
MEDIAN ISLANDS, ROAD BACKUPS, AND PARKS**

WHEREAS, as described in the City of San José (“City”) Community Forest Management Plan (“CFMP”), tree canopy cover in San José decreased from 15.36 percent in 2012 to 13.54 percent in 2018; and

WHEREAS, since the CFMP adoption, the City’s Departments of Transportation and Parks, Recreation and Neighborhood Services are on track to plant and establish over 2,000 trees per year by partnering with Our City Forest and contractors; and

WHEREAS, due to high demand for good quality tree stock in the nursery industry, sourcing trees is one of the challenges faced when executing planting projects; and

WHEREAS, Google, LLC (“Google”) has cultivated a surplus of high-quality native trees that will make excellent shade trees for San José, and is offering to donate 544 trees, valued at \$258,315, to be planted throughout the City in median islands, road backups, and parks; and

WHEREAS, areas for planting these trees have been identified and prioritized, especially in areas with the lowest canopy cover or where trees have been lost, and the trees will be planted by Our City Forest and contractors; and

WHEREAS, Google may be a vendor and/or lobbyist employer and Google employees may be registered lobbyists. Notwithstanding the foregoing, the City can accept, and

Google can provide, this donation under applicable laws. This donation will not prevent Google or its affiliates from supplying products or services to City; and

WHEREAS, the City wishes to accept the donation of 544 street trees from Google for the specified purpose;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

The City of San José hereby accepts the donation from Google, LLC of 544 trees that are valued at \$258,315 to be planted throughout the City in median islands, road backups, and parks.
