**SUBJECT: PUBLIC HEARING ON THE 2024 WEED ABATEMENT  
COMMENCEMENT REPORT AND REMOVAL OF WEEDS OR REFUSE**

## **RECOMMENDATION**

Conduct a Public Hearing and adopt a resolution:

- (a) Overruling any and all objections to the 2024 Weed Abatement Commencement Report; and
- (b) Directing the County of Santa Clara's Consumer and Environmental Protection Agency - Weed Abatement Program to abate the seasonal and/or recurrent public nuisances on those properties identified in the 2024 Weed Abatement Commencement Report pursuant to Chapter 9.12 of Title 9 of the San José Municipal Code and the Weed Abatement Program Agreement between the City of San José and the County of Santa Clara.

## **SUMMARY AND OUTCOME**

Conducting a public hearing and adoption of the recommended resolution will overrule any objection to the 2024 Weed Abatement Commencement Report (Report) (**Attachment**) and enables the County of Santa Clara's (County) inspectors and contractor to commence the Weed Abatement Program for the 2024 season in compliance with an existing agreement between the City of San José and the County's Consumer and Environmental Protection Agency - Weed Abatement Program. The program will result in the abatement of weeds and dry hazardous vegetation on vacant parcels, reducing the threat of fire and risk to persons and property.

## **BACKGROUND**

On December 12, 2023, the City Council adopted Resolution 2023-452 accepting the Report, compiled by the County's Consumer and Environmental Protection Agency - Weed Abatement Program, which identified private property vacant parcels to be included in the Weed Abatement Program. The adopted resolution declared that certain noxious or dangerous seasonal and recurrent weeds and refuse on properties identified in the Report are a public nuisance and directed the County's Consumer and Environmental Protection Agency - Weed Abatement Program to notify owners of real properties identified in the Report of this public hearing. This public hearing is the opportunity for property owners to object to the inclusion of their property in the Weed Abatement Program, as well as the proposed removal or abatement of weeds and refuse from their property, as provided in Section 9.12.190 of the San José Municipal Code.

## **ANALYSIS**

Pursuant to Chapter 9.12 of Title 9 of the San José Municipal Code and the Weed Abatement Agreement between the City of San José and the County, this public hearing to hear any objections from property owners to the inclusion of their property in the County's Consumer and Environmental Protection Agency - Weed Abatement Program and/or the proposed removal or abatement of weeds and refuse from their property is the next step in the Weed Abatement Program process. The County's Consumer and Environmental Protection Agency provided written notice to each property owner listed in the Report, including the date, time, and location of this hearing; information regarding the program and fees; and clear guidelines to facilitate compliance.

Historically, few property owners appear to raise objection to their parcels being included in the Weed Abatement Program. Property owners that appear generally have recently purchased the property and seek clarification regarding the Weed Abatement Program or wish to advise City Council that they will comply in removing the hazardous vegetation within the guidelines as set forth in the program. Even though a parcel is included in the Report, property owners have been notified of minimum fire safety standards and will still have the option of abating weeds and dry hazardous vegetation themselves before March 1, 2024. Property owners are responsible for an annual fee of \$96.00 to cover the cost of the compliance inspection. Parcels found not compliant on or after the March 1, 2024 deadline will be charged a processing fee of \$546.00 and the property will be scheduled for abatement by the County contractor. If the property owner abates the weeds before the County contractor performs the work, no further charges are assessed. If the County contractor performs the work as scheduled, the property owner is assessed the contractor's charges, plus an additional County administrative fee of \$884.00 per parcel. The property owner will be given an opportunity to dispute any charges proposed for assessment on the property at a public hearing before the Appeals Hearing Board held on or about July 2024. The fees approved for assessment by resolution of the Appeals Hearing Board will be added to the property tax bill and collected by the County.

The Department of Planning, Building, and Code Enforcement reviewed the Report and recommends that any objections from property owners to the inclusion of their property identified in the Report in the County's Weed Abatement Program and/or the proposed removal of the seasonal and recurrent weeds and refuse from the property be overruled. Further, staff recommends that City Council direct the Director of Planning, Building, and Code Enforcement to notify the County's Consumer and Environmental Protection Agency - Weed Abatement Program to abate the public nuisances on properties identified in the Report pursuant to Chapter 9.12 of Title 9 of the San José Municipal Code and the Weed Abatement Agreement between the City of San José and the County.

### **EVALUATION AND FOLLOW UP**

Following the December 12, 2023 City Council meeting, the County's Consumer and Environmental Protection Agency sent a letter with a Return Reply Form to each property owner listed in the Report with a vacant parcel in the City of San José. The Return Reply Form allowed the owner to request that the County contractor perform weed abatement work on their parcel or attest that the property owner intends to maintain their parcel in a manner consistent with the Minimum Fire Safety Standards from March 1, 2024 through the end of the fire season (typically runs through October).

### **COORDINATION**

This memorandum has been coordinated with the City Attorney's Office, the City Manager's Budget Office, and the County's Consumer and Environmental Protection Agency - Weed Abatement Program.

### **PUBLIC OUTREACH**

As directed by City Council on December 12, 2023, the County's Consumer and Environmental Protection Agency - Weed Abatement Program mailed a notice to the property owners of all parcels in the Weed Abatement Program. The notice advised property owners of the requirement to remove seasonal and recurrent weeds and refuse, of the Minimum Fire Safety Standards by which parcels must be maintained, and the costs that would be incurred should the County's Consumer and Environmental Protection Agency have to abate the public nuisance created by the weeds and refuse. The notice also advised owners of the date, time, and place of this public hearing during which they may object to the placement of their property in the program.

This memorandum will be posted on the City's Council Agenda website for the February 6, 2024 City Council meeting.

**A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE OVERRULING ALL OBJECTIONS TO THE 2024 WEED ABATEMENT COMMENCEMENT REPORT AND DIRECTING THE COUNTY OF SANTA CLARA CONSUMER AND ENVIRONMENTAL PROTECTION AGENCY, WEED ABATEMENT PROGRAM, TO ABATE THE SEASONAL AND/OR RECURRENT PUBLIC NUISANCES ON THOSE PROPERTIES IDENTIFIED IN THE REPORT PURSUANT TO CHAPTER 9.12 OF TITLE 9 OF THE SAN JOSE MUNICIPAL CODE AND THE WEED ABATEMENT AGREEMENT BETWEEN THE CITY OF SAN JOSE AND THE COUNTY OF SANTA CLARA**

**WHEREAS**, on December 12, 2023, the City Council of the City of San José (“City Council”) received evidence and by its Resolution No. 2023-452: (a) found and determined that noxious and/or dangerous weeds which are seasonal and/or recurrent are growing or are likely to grow upon the streets, parkways, sidewalks or private properties, all as shown in the Weed Abatement Commencement Report for the year 2024 (“Report”), compiled by the County of Santa Clara’s Consumer and Environmental Protection Agency, Weed Abatement Program, which was submitted to the City Council on December 12, 2023; (b) declared that said seasonal and/or recurrent weeds, growing or likely to be growing, and refuse, situated or likely to be situated on those properties identified in the Report constitute a public nuisance that must be abated by removal of said weeds and refuse in order to protect the health, safety and welfare of residents of the City of San José; and (c) directed the County of Santa Clara’s Consumer and Environmental Protection Agency, Weed Abatement Program, to give notice of a public hearing on February 6, 2024 at 1:30 P.M. before the City Council pursuant to Chapter 9.12 of Title 9 of the San José Municipal Code; and

**WHEREAS**, on February 6, 2024, the City Council heard and considered all objections from property owners to the inclusion of their properties in the County of Santa Clara

Consumer and Environmental Protection Agency's Weed Abatement Program, and the proposed removal of weeds and refuse from their properties at a public hearing held pursuant to Chapter 9.12 of Title 9 of the San José Municipal Code;

**NOW, THEREFORE,** BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

1. Any and all objections to the proposed removal of said seasonal and recurrent weeds and refuse from said streets, parkways, sidewalks, and private property in the City of San José as listed on the Weed Abatement Commencement Report for the year 2024 of seasonal and recurrent weeds and refuse have been heard and are hereby overruled.
2. The Weed Abatement Commencement Report for the year 2024 prepared by the County of Santa Clara's Consumer and Environmental Protection Agency is hereby accepted and confirmed.
3. The Director of Planning, Building and Code Enforcement is hereby directed to:  
(a) cause the County of Santa Clara's Consumer and Environmental Protection Agency, Weed Abatement Program to abate the public nuisances or cause them to be abated by having said weeds and refuse removed from said streets, parkways, sidewalks and private properties; and (b) keep and maintain the accepted Weed Abatement Commencement Report for the year 2024 prepared by the Santa Clara County Consumer and Environmental Protection Agency on file at the Code Enforcement Division of Planning, Building and Code Enforcement for full particulars respecting the location of said streets, parkways, sidewalks and private properties.
