**SUBJECT: MASTER AGREEMENTS WITH TOWILL, INC. AND HMH ENGINEERS
FOR LAND SURVEYING AND MAPPING CONSULTANT SERVICES**

RECOMMENDATION

Adopt a resolution authorizing the City Manager or her designee to negotiate and execute master agreements with Towill, Inc. and HMH Engineers for Citywide land surveying and mapping consultant services from the date of execution through March 31, 2027, in an amount not to exceed \$2,000,000 for each agreement.

SUMMARY AND OUTCOME

The approval of this resolution authorizing the City Manager or her designee to award the master consultant agreements to Towill, Inc. and HMH Engineers enables the City to provide land surveying and mapping services during times of peak workload. The consultants will provide services in the areas of project control, topography, right-of-way/property, and construction staking on an as-needed basis for the Citywide Pavement Maintenance Program.

BACKGROUND

The Department of Public Works, Survey Section, has identified the need to secure new consultant master agreements with qualified land surveying firms to address the surveying and mapping needs required to support the ongoing Citywide pavement plan. The City of San José began an annual Pavement Maintenance Plan that includes a number of new initiatives and project zones that will require the services of qualified land surveying firms. The Pavement Maintenance Program will maintain or repave approximately 2,000 San José streets by 2028, to improve the quality and condition of local and major streets in conjunction with the 2040 General Plan. The results of the annual Pavement Maintenance Plan are anticipated to yield a

new list of capacity improvement and high priority zones, which requires surveying and mapping support services over the next three years. Considering the number of future pavement projects, in addition to the existing workload from ongoing projects, and the current market rate for these consultant services, the proposed master agreement compensation limit is set to \$2,000,000 each. This is projected to meet the City's Pavement Maintenance Program needs during the three-year term.

ANALYSIS

A Request for Qualifications for consultant services to provide surveying and mapping services was advertised on August 15, 2023. The City received Statements of Qualifications from three firms by the September 12, 2023 deadline. Staff from the Public Works Department conducted a selection process for consultant services in accordance with the evaluation criteria specified in the Request for Qualifications.

The firms were evaluated and ranked as follows:

Based on the projected need for land surveying and mapping services over the next three years, staff recommends awarding agreements to the top two firms.

Under the proposed master agreements, consultant services will be initiated by authorized service orders detailing the specific scope of services, schedule, and compensation, along with the appropriate funding source(s) for the projects.

COST SUMMARY/IMPLICATIONS

No budget actions are being requested as part of this recommendation. The project-specific service orders are to be funded by the 486 Pavement Maintenance - VTA Measure B 2016 fund. Costs are anticipated to be evenly split among all three years; \$666,000 per year for both Towill, Inc. and HMH Engineers. There are no cost implications to the General Fund, as a result of this action.
