

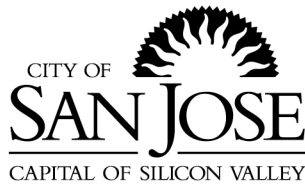
## 2.15 Amicus brief in *City of Chicago v. Westforth Sports, Inc.*

### **Recommendation:**

Authorize the City Attorney to join an Amicus Curiae brief for submission to the First Judicial District in the Appellate Court of Illinois in *City of Chicago v. Westforth Sports, Inc.*, Case No. I-23-1908, supporting the plaintiff-appellant's arguments to reverse the Illinois trial court's dismissal holding that it does not have jurisdiction over an Indiana federal firearms licensee that has sold hundreds of straw-purchased guns used to commit crimes in Chicago. The brief will be submitted on behalf of the Giffords Law Center to Prevent Gun Violence, the Brady Center to Prevent Gun Violence, and cities participating as Amicus Curiae.

## **RECOMMENDATION**

Ratify authorizing the City Attorney to join an Amicus Curiae brief for submission to the First Judicial District in the Appellate Court of Illinois in *City of Chicago v. Westforth Sports, Inc.*, Case No. I-23-1908, supporting the plaintiff-appellant's arguments to reverse the Illinois trial court's dismissal holding that it does not have jurisdiction over an Indiana federal firearms licensee that has sold hundreds of straw-purchased guns used to commit crimes in Chicago. The brief is to be submitted on behalf of the Giffords Law Center to Prevent Gun Violence, the Brady Center to Prevent Gun Violence, and cities participating as Amicus Curiae.

## **BACKGROUND**

An opportunity arose for the City of San Jose to join the Giffords Law Center and the Brady Center, as well as some other cities, on an amicus brief being drafted by the Proskauer Rose LLP law firm in support of the City of Chicago in its lawsuit filed against Westforth Sports, Inc. ("Westforth"). Westforth is a federally licensed firearm dealer doing business in the State of Indiana. The City of Chicago has alleged that Westforth failed to follow federal protocols to stop illegal sales of firearms pursuant to the Gun Control Act of 1968. Specifically, the lawsuit alleges that Westforth failed to meet its legal obligations and the industry standard of care in preventing "straw purchases" of firearms, that is, sales for which the weapons were actually purchased for someone else, often a person prohibited from owning a firearm.

## **ANALYSIS**

Straw purchasing is illegal under Federal law and California law. In 2021, the San Jose City Council adopted an ordinance regulating the retail sale, lease and transfer of firearms and firearm ammunition in the City of San Jose. That ordinance contains a provision for training employees of firearms dealers in the City to question and

determine whether each potential customer, who is not a peace officer, is attempting to buy a firearm for another person. (SJMC section 6.90.370) The fact that an Indiana based business is not complying with federal law and industry practices is alleged to have led to an increase in firearms and firearm-related crime and violence in the City of Chicago. San Jose has a similar interest in ensuring that out of state licensed firearms dealers are complying with federal law and preventing straw purchases.
