RECOMMENDATION

2. Approve and accept donations from various individuals, businesses, or community groups to support the events.
3. Place the item on the June 4, 2024, Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The 50th Anniversary Celebration of the San Jose Earthquakes will be held at the Seven Trees Community Center and Solari Park on June 8, 2024 at 9:00 AM, and is sponsored by Councilmember Bien Doan. This special event serves to celebrate the 50th anniversary of the San Jose Earthquakes. The event is free and open to the public and will include a soccer skills camp, health fair, meet and greet with professional players, music and food trucks.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Bien Doan will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 7, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
