**Recommendation:**

## RECOMMENDATION

- (a) Adopt a resolution authorizing the City Manager, or her designee, to accept a donation in the amount of \$36,157 from Almaden Valley Rotary Club Endowment, a 501(c)(3) organization to the City Gift Trust Fund to support project development for the All-Inclusive Playground at Almaden Lake Park and execute any necessary documents to accept the donation.
- (b) Adopt the following 2024-2025 Appropriation Ordinance and Funding Sources Resolution amendments in the Gift Trust Fund:
  - (1) Re-establish the Almaden Lake Park appropriation to the Parks, Recreation, and Neighborhood Services Department in the amount of \$36,157; and
  - (2) Increase the estimate for Other Revenue by \$36,157.

## SUMMARY AND OUTCOME

The recommended action will recognize and make available a gift of \$36,157 from the Almaden Valley Rotary Club Endowment, a 501(c)(3) organization, to the All-Inclusive Playground–Almaden Lake Park Project in the Gift Trust Fund.

**BACKGROUND**

The All-Inclusive Playground at Almaden Lake Park was initially approved as part of the 2019-2020 budget and has a current total project budget of \$2.9 million, with the project expected to complete in 2024-2025.

The Almaden Valley Rotary Club Endowment (Rotary) partnered with the City of San José (City) to fundraise for the All-Inclusive Playground at Almaden Lake Park. Fundraising will supplement the City’s existing resources to deliver the project. On April 12, 2022, City Council approved a Gift Trust Fund donation in the amount of \$162,000. As of March 2024, Rotary has raised an additional \$36,157 and intends to contribute to the project via the Gift Trust Fund.

**ANALYSIS**

The All-Inclusive Playground at Almaden Lake Park has received widespread support from the community and region. Rotary committed to fundraising for the park to supplement the budget and provide additional furnishings in the playground. The donation of the funds will be placed in the City’s Gift Trust Fund and subsequently appropriated to support the project.

**EVALUATION AND FOLLOW-UP**

No additional follow-up action with City Council is expected.

**COST SUMMARY/IMPLICATIONS**

The donation of \$36,157 will be received within the Gift Trust Fund and is designated to be spent on enhancements at the All-Inclusive Playground at Almaden Lake Park.
