The Clean Water Act

- The Federal Water Pollution Control Act of 1948 was the first major U.S. law to address water pollution. Growing public awareness and concern for controlling water pollution led to sweeping amendments in 1972. As amended in 1972, the law became commonly known as the Clean Water Act
- **Prohibits the discharge of any pollutant, including trash,** into the waters of the United States



Overview – Stormwater Permit Mandates

- ❑ **Effectively prohibit** the discharge of materials other than stormwater into storm drain systems and **watercourses or any place where they would be eventually transported to surface waters**
- ❑ Timely **implementation** of trash control measures and other actions to reduce trash loads
- ❑ Achieve **100% Trash Load Reduction** from 2009 baseline by June 20, 2025
- ❑ Address non-stormwater **discharges associated with unsheltered homeless populations**



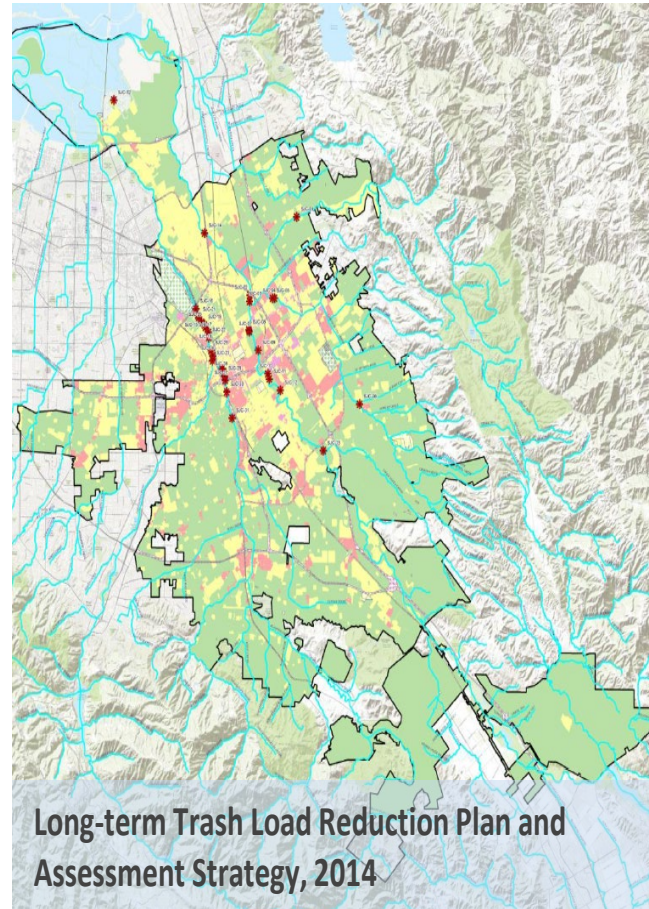

City of San José Direct Discharge Plan

Report Annually thru the end of the Permit term, June 30, 2027

- **Human Centered** Homeless Prevention, Support and Management programs based on lessons learned to **provide housing and outreach services** for City residents experiencing unsheltered homelessness;
- An Enhanced Encampment Management Strategy that increases the City's ability to **provide trash and sanitary services** to unsheltered populations in **waterways and lived-in vehicles**;
- **Updated mapping** to help the City make progress providing services to unsheltered individuals, removing trash from waterways, and **protecting waterways from re-encampment**; and
- A new **Enhanced Neighborhoods and Waterways Approach** program to address issues arising from unsheltered populations, in part by developing housing alternatives located **away from creeks**, including safe parking areas and **new temporary and permanent housing**.

Dear Ms. Morse:

We have reviewed the City's revised Direct Trash Discharge Control Plan (revised Plan), submitted on March 6, 2024, pursuant to Provision C.10.f.ii of the Municipal Regional Stormwater NPDES Permit, Order No. R2-2022-0018 (MRP). The revised Plan meets the expectations set forth in the MRP because the combination of actions present in the revised Plan is expected to make reasonable, incremental progress towards addressing challenges associated with unsheltered homelessness, including providing housing and services, and addressing water quality impacts, with long-term solutions. This letter provides notice that the revised Plan is acceptable to the Executive Officer.

With the City's implementation of the revised Plan, pursuant to MRP Provision C.10.g.viii, the deadline for the City to achieve the required 100 percent reduction of trash discharged through its storm drain system is extended to December 31, 2025. In addition, the City may claim up to a 15 percent offset, through June 30, 2025, toward meeting the MRP's trash control requirements.

The Plan provides an acceptable description, pursuant to Provision C.10.f.ii, of existing and upcoming measures that are intended to protect waterways while working towards

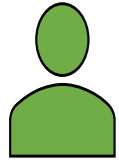

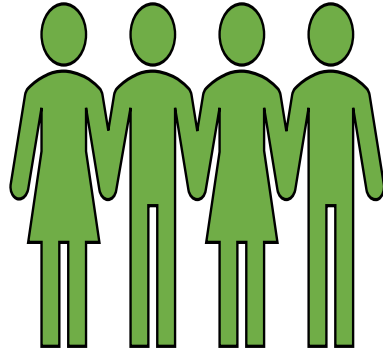
Stormwater and Managing and Ending Unsheltered Homelessness

 - Getting the right people on the team from across departments

 - Co-locating key team members to speed communication and build trust
- **Clarifying Objectives** and setting measurable Key Results each quarter (OKRs) that will guide the work and be communicated out,
