BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The 9 events were/will be free, open to the public, and sponsored by Councilmember Peter Ortiz.

ANALYSIS

The Mayfair Community Center Spring Fling connected families of East San José to an Easter Egg Hunt and Resource Fair. The event was held on March 23rd, 2024, at the Mayfair Community Center. The Toyon Dumpster Day allowed residents of the district to discard unwanted items. The event was held on March 30th, 2024, at Toyon Elementary School. The One ComUNITY Event connected residents of East San José to a cultural celebration of the East Side and Resource Fair. The event was held on April 6th, 2024, at Robert Sanders Elementary School. The Grammercy Dumpster Day allowed residents of the district to discard unwanted items. The event was held on April 6th, 2024, at Grammercy Place. The Cinco de Mayo Business Outreach meeting allowed business owners of the district to connect with District 5 staff prior to the Cinco de Mayo event, gaining valuable information about the event and road closures. The event was held on April 16th, 2024, at Pizza Presidente. The Dobern Neighborhood Dumpster Day allowed residents of the district to discard unwanted items. The event was held on April 27th, 2024, at Grammercy Place. The Black April Recognition Event allowed residents of the East Side to honor and remember Black April, a somber day for the Vietnamese Refugee community. The LEAF Educational Townhall allowed residents of the district to learn about educational funding disparities. The event was held on May 2nd, 2024, at the Mayfair Community Center. The event was held on April 30th, 2024, at the Alum Rock Library. The Educational Park Resource Fair allowed residents of the district to gain access to valuable resources and information provided by various service agencies. The event was held on April 30th, 2024, at the Educational Park Library. The Viva Calle Event allowed residents of the district to explore the East Side of San José via bike, foot, etc. The event promoted the vibrancy of the district. The event was held on June 9th, 2024, at Santa Clara St., Alum Rock Avenue, and White Rd. The Alum Rock Culture Night Marker will allow residents of the district to engage in a Night Market, helping promote the socioeconomic vibrancy of the East Side of San José. The event will be held on June 22nd, 2024, at the Alum Rock Village. Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Peter Ortiz will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 5, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
