

3.3 Actions Related to Vice Mayor and Councilmembers' Travel to Dublin, Ireland for the Sister City Delegation.

Recommendation: (a) Approval to consider the recommendation to waive a provision of Policy 9-5 limiting approval of travel to five Councilmembers pursuant to Policy 0-1, Council Policy Manual.

(b) Approve waiver of Council Policy 9-5 to allow more than five Councilmembers to attend the Dublin Sister City Trip and the cancellation of Council and Committee meetings due to lack of quorum.

OUTCOME

Approval of this action will authorize the spending of City funds on travel for the Sister City Delegation travel to Dublin, Ireland.

BACKGROUND

The San Jose has a strong sister city relationship with Dublin, Ireland which was established by the Council in 1986. The sister city linkage has resulted in San Jose-Dublin collaboration in education, economic development, the arts, community engagement, government, and other initiatives. The last trip to Dublin by the City of San José representatives occurred in 2018.

ANALYSIS

Pursuant to City Council Policy 9-5, the City Council may appoint up to five (5) elected members as long as it does not result in a cancellation of a meeting. Since six (6) Councilmembers have indicated an interest in attending, the Council will need to discuss and select which Councilmembers will attend to represent the City of San José. Names on the recommendation are in the order the request was received by the City Clerk's Office. Council Policy 0-1 provides for the ability of Council to vote to waive any provision of a Council Policy with an affirmative vote of six members of Council. If Council declines to waive Council Policy 9-5 C.3, only up to five member of the Council may be approved for official travel.

Council Policy 9-5 C.3.

Official City Representative: When travel to a conference, convention, or other similar event is authorized and undertaken for a municipal purpose, the Council or Commission Chair must specifically designate one or more Councilmembers or City Commissioners, respectively, to act as the official representatives of the City of San José. Council may approve up to five (5) of its elected members to travel for Official or Unofficial Delegation Travel, as long as it does not result in cancellation of a Council or Council Committee meeting due to lack of quorum. Council Staff travelling on Official or Unofficial

Delegation Travel shall notify the City Clerk approximately six (6) weeks prior to the travel date, and the information shall be placed in the memorandum from the City Clerk regarding the Mayor/Council Travel on Official or Unofficial Delegation Travel.

The following City meetings would not have quorum due to the requests for excused absences.

Council Travel Policy 9-5 provides, in relevant part, “For proposals requesting funding from the Mayor/Council Travel Budget, the City Clerk’s Office will submit a statement with the travel request showing how much uncommitted funds remain in the Mayor/Council Travel Budget and how much year-to-date each trip has cost.”

The Mayor/Council Travel Budget fund was \$10,000 for FY 24-25. To date, there is an estimated

\$2,000 travel expense for the League of California Cities Annual Conference in October 2024, which leaves an estimated balance of \$8,000.

EVALUATION AND FOLLOW-UP

The Councilmembers may be asked to submit or present a report to Council on the results of their travel within fifteen (15) working days of their return to San José. Such reports are required if the Mayor/Council Travel Budget has been used for the travel. The report may include, but is not limited to: a listing of any workshops, seminars, presentations, speeches or other sessions attended with descriptions of information gathered; a listing of any presentations made with a description of information presented; a listing of individuals or groups with whom the Councilmember met while traveling including subjects addressed at the meeting and any outcome of the meeting.

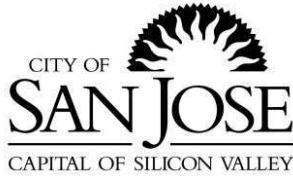

RECOMMENDATION

Approve Councilmember Pam Foley as the Delegation Leader to lead the Sister City delegation to Dublin, Ireland from September 9, 2024 to September 12, 2024, and approve related travel costs from the Mayor/Council Travel Budget.

BACKGROUND

On September 18, 2018, the City Council amended the Council Travel Policy 9-5 that permits the Mayor to designate a Councilmember representative to serve as the Delegation Leader in the event he or she is unable to travel to a Sister City or other City-organized mission. The policy also provides that the Mayor/Council Travel Budget will be used for the Delegation Leader's travel-related costs, subject to Council approval.

Dublin City Council confirmed that the Lord Mayor, Chief Executive, and senior executives would like to welcome a San José delegation to Dublin this September to discuss a variety of topics of mutual interest. Dublin is a very historic city and has a thriving economy which is driven by the technology sector. The City of San José has collaborated with Dublin on many initiatives since the sister city affiliation was established in 1986.

I will be unable to attend. Councilmember Foley has agreed to lead the Sister City Delegation to Dublin in my place.

Purpose: San José has a strong sister city relationship with Dublin, Ireland, which was established by the City Council in 1986. The sister city linkage has resulted in San José-Dublin collaboration in education, economic development, the arts, community engagement, government, and other initiatives. The four-day stay will include meetings with the Dublin City Council and Government, the Irish National Government, and the Dublin Chamber of Commerce. This will be my first delegation travel to Dublin, Ireland, as a Director on the Sister Cities International (SCI) Board. SCI plays a crucial role in building bridges between communities across the globe while continuing to advance the ideals and mission championed by President Dwight Eisenhower, by promoting cultural exchange, economic cooperation, and mutual understanding. SCI contributes to a more interconnected and harmonious world.
