


2.14 Amendments to Consultant Master Agreements for Architectural Services for Non-Essential City Facilities Projects.

Recommendation:

Adopt a resolution authorizing the City Manager or her designee to negotiate and execute amendments to the existing Master Agreements for consultant services with Anderson Brule Architects, Inc. (CPMS Contract No. 9031-A), Studio G Architects, Inc. (CPMS Contract No. 9031-B), Group 4 Architecture, Research and Planning, Inc. (CPMS Contract No. 9031-C), and ELS Architecture and Urban Design (CPMS Contract No. 9031-D), extending the term of each contract by up to three years and increasing the total maximum compensation limit for each contract by various amounts up to \$500,000 each.

SUBJECT: Amendments to Consultant Master Agreements for Architectural Services for Non-Essential City Facilities Projects

RECOMMENDATION

Adopt a resolution authorizing the City Manager, or her designee, to negotiate and execute amendments to the existing Master Agreements for consultant services with Anderson Brule Architects, Inc. (CPMS Contract No. 9031-A), Studio G Architects, Inc. (CPMS Contract No. 9031-B), Group 4 Architecture, Research and Planning, Inc. (CPMS Contract No. 9031-C), and ELS Architecture and Urban Design (CPMS Contract No. 9031-D), extending the term of each contract by up to three years and increasing the total maximum compensation limit for each contract by various amounts up to \$500,000 each.

BASIS FOR RECOMMENDATION

On June 4, 2019, City Council approved the award of master agreements with four architectural consultant firms: Anderson Brule Architects, Inc.; Studio G Architects, Inc.; Group 4 Architecture, Research and Planning, Inc.; and ELS Architecture and Urban Design. Each original master agreement for architectural consultant services was in the amount not to exceed \$3,000,000 with a term end date of December 31, 2024. The master agreements were procured through a request for qualifications process.

Approval of the first amendment to Anderson Brule Architects, Inc.'s master agreement will extend the contract term from December 31, 2024 to December 31, 2027 with no increase in the total maximum compensation limit. Extending the contract term will allow the City to retain the consultant on the current Biblioteca Latinoamericana Improvements project so it can provide the full scope of services on the project as it proceeds through design, construction, and project completion phases.

Approval of the first amendment to Studio G Architects, Inc.'s master agreement will extend the contract term from December 31, 2024 to December 31, 2026 and will increase the total maximum compensation limit from \$3,000,000 to \$3,500,000. Two projects, the New Muni Water Office Building and Guadalupe River Park Ranger Station projects, under Studio G Architects, Inc. experienced delays due to design modification required by the unforeseen conditions experienced during construction and additional time needed for permit review and approval with Valley Water, respectively. Additionally, the Central Service Yard Fuel Island project is currently in the design phase and construction is anticipated to be completed by end of 2026. Extending the contract term and increasing the total compensation will allow the City to retain the consultant on the project so it can provide full construction support services through construction completion.

A first amendment to Group 4 Architecture, Research and Planning, Inc.'s master agreement was approved on February 27, 2024, which increased the total maximum compensation limit of its master agreement from \$3,000,000 to \$3,350,000 with no extension of the contract term. Approval of the second amendment to its master agreement will extend the contract term from December 31, 2024 to December 31, 2026 and increase the total maximum compensation limit from \$3,350,000 to \$3,850,000. Extending the term will allow the City to retain the consultant for the support services needed for the Police Department Training Center Relocation Project and the Almaden Lake All Inclusive Playground Project, both of which are currently in construction.

Approval of the first amendment to ELS Architecture and Urban Design's master agreement will extend the contract term from December 31, 2024 to December 31, 2025 with no increase in the total maximum compensation limit. The Emergency Interim Housing project at the Santa Clara Valley Transportation Authority's Cerone Bus Yard is currently in the design phase and is anticipated to be completed in 2025. Extending the contract term will allow the City to retain the consultant on the project so it can provide full construction support services through construction completion.
