

## **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The District 4 Community Emergency Response Team (CERT) Meet & Greet Event was held on Thursday, August 22, 2024 from 6:30pm to 7:30pm at the Berryessa Community Center. The event aimed to boost community participation in the CERT program, fostering a spirit of neighbors helping neighbors in District 4. The event was free and open to the public.

The District 4 Annual Pumpkin Giveaway will be held on Monday, October 21, 2024 from 5:00pm to 7:00pm at 1376 Piedmont Road. The event will offer free pumpkins to families, provide refreshments, and feature crafts for all ages. This event is free and open to the public.

The District 4 Christmas in the Park Event will be held on Thursday, December 12, 2024 from 6:00pm to 8:00pm in Plaza de Cesar Chavez. The purpose of this event is to bring San Jose residents together to create lasting family memories, bond with their neighbors, and celebrate the holiday spirit with performances by District 4 student musicians and entertainers. This event is free and open to the public.

### **ANALYSIS**

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember David Cohen will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 4, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
