

2.9 Actions Related to the Purchase Order with Pierce Manufacturing, Inc. for an Aircraft Rescue Fire Fighting Vehicle.

Recommendation:

(a) Adopt a resolution authorizing the City Manager or her designee to:

(1) Execute a purchase order with Pierce Manufacturing, Inc. (Appleton, WI) for an Aircraft Rescue Fire Fighting Vehicle and associated equipment, for a one-year term beginning on or about September 25, 2024, ending on or about September 24, 2025, for a total not-to-exceed amount of \$2,200,000;

(2) Approve a contingency of \$500,000 for unanticipated modifications to the Aircraft Rescue Fire Fighting Vehicle specifications and equipment subject to the appropriation of funds; and

(3) Exercise up to six one-year options to extend the term of the purchase order with the last option year ending on or about September 24, 2031, subject to the appropriation of funds.

(b) Adopt the following 2024-2025 Funding Sources Resolution and Appropriation Ordinance amendments in the Airport Capital Improvement Fund:

(1) Increase the estimate for Revenue from Federal Government by \$97,000; and

SUMMARY AND OUTCOME

The Fleet Management Division, Public Works Department, is responsible for overseeing the City's vehicle fleet, including various apparatuses used by the Fire Department to respond to fire emergencies and other public safety issues. The City requires a new Aircraft Rescue Fire Fighting Vehicle (ARFFV) to replace an existing piece of equipment due to age and utilization. The new apparatus will provide the Fire Department with modernized and advanced tools and equipment to continue providing responses to emergencies at the Airport to satisfy the Federal Aviation Authority's (FAA) minimum ARFFV count requirement.

BACKGROUND

The City's current fleet of four ARFFVs range in age from 7 years to 23 years old. The fire equipment manufacturing industry forecasts ARFFV has an expected service life of 10-12 years. In July 2023, the City submitted a six-year Airport Capital Improvement Plan to the FAA for Federal Fiscal Years 2023-2024 through 2028-2029, which included funding for the replacement of an ARFFV.

ANALYSIS

In April 2024, a competitive Request for Bids was facilitated by the Finance Department to procure a new ARFFV and associated equipment. The Request for Bids provisioned for a one-year initial term and an additional six one-year options for the City to extend the term. One responsive bid was submitted, and no protests were received. The sole bidder did not qualify for the City's local or small business preferences. Staff recommends award to Pierce Manufacturing, Inc. pursuant to the bidding procedures of the San José Municipal Code, Section 4.12.310.B(1). Approval of this recommendation ensures the City receives this essential equipment. The budget actions included in this memorandum appropriately align with the available FAA grant funding of \$1.7 million and the City's local share funding of \$492,000 for a total cost of \$2,200,000.

EVALUATION AND FOLLOW-UP

This memorandum will not require any follow-up from staff.

COST SUMMARY/IMPLICATIONS

The table below identifies the total amount of the purchase order for the initial term. Any use of the project contingency of \$500,000 for unanticipated modifications to the ARFFV specifications and equipment that may be needed will be requested as part of the City's annual budget process and will be subject to the future appropriation of funds.




