

2.11 Actions Related to the Purchase Order with Iteris, Inc. for Modular Video Detection Systems and Accessories.

Recommendation:

Adopt a resolution authorizing the City Manager or her designee to:

- (a) Execute a purchase order with Iteris, Inc. (Santa Ana, CA) for modular video detection systems and accessories, for a one-year term beginning on or about June 11, 2024, ending on or about June 10, 2025, for a not-to-exceed amount of \$720,000; and
 - (b) Exercise up to six one-year options to extend the term of the purchase order with the last option year ending on or about June 10, 2031, subject to the appropriation of funds.

SUBJECT: ACTIONS RELATED TO THE PURCHASE ORDER WITH ITERIS, INC. FOR MODULAR VIDEO DETECTION SYSTEMS AND ACCESSORIES

RECOMMENDATION:

Adopt a resolution authorizing the City Manager or her designee to:

- a) Execute a purchase order with Iteris, Inc. (Santa Ana, CA) for modular video detection systems and accessories, for a one-year term beginning on or about June 11, 2024, ending on or about June 10, 2025, for a not-to-exceed amount of \$720,000; and
- b) Exercise up to six one-year options to extend the term of the purchase order with the last option year ending on or about June 10, 2031, subject to the appropriation of funds.

BASIS FOR RECOMMENDATION:

The Department of Transportation requires modular video detection systems to help improve and optimize vehicle traffic flow. Each modular video detection system includes video detection cameras, a processor, accompanying software, and a CCTV LED monitor. The modular video detection systems will be used at signalized intersections to detect the presence of approaching vehicles for the purpose of actuating traffic signals for efficient operations. These systems also allow remote video monitoring; collection of vehicle speed data; and vehicle, bicycle, and pedestrian counts. Detection hardware for the new systems will be mounted on traffic poles, allowing easier access and reduced maintenance over traditional, in-ground, detector loop cables.

In December 2023, a competitive Request for Bids was released by the Finance Department to procure these products. The Request for Bids provisioned for a one-year initial term and an additional six one-year options for the City to extend the term. One responsive bid was submitted, and no protests were received. The sole bidder did not qualify for the City's local or small business preference. Staff recommends award to Iteris, Inc. as the sole responsive and responsible bidder pursuant to the bidding procedures of the San José Municipal Code, Section 4.12.310.B(1). Approval of this recommendation ensures the City receives these essential products.
